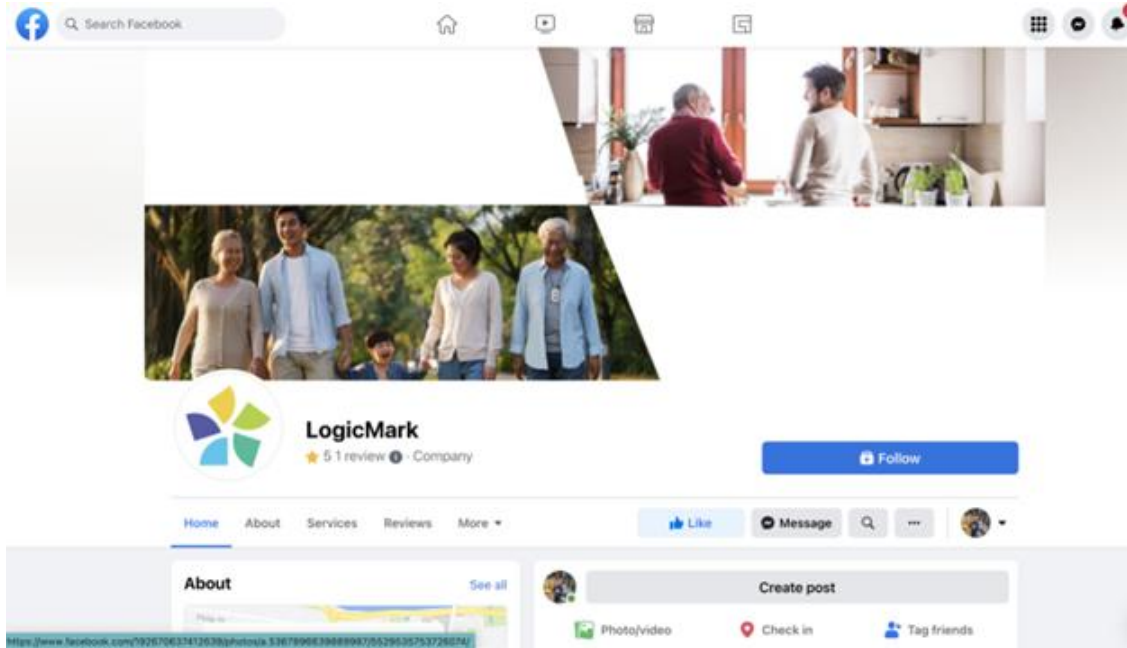


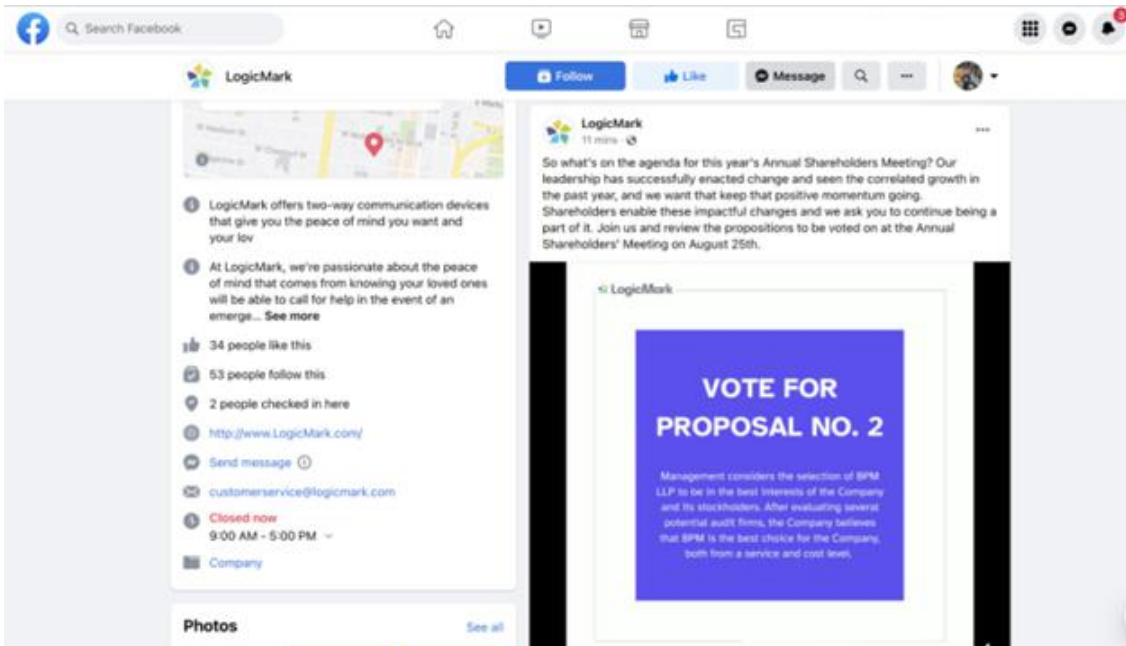
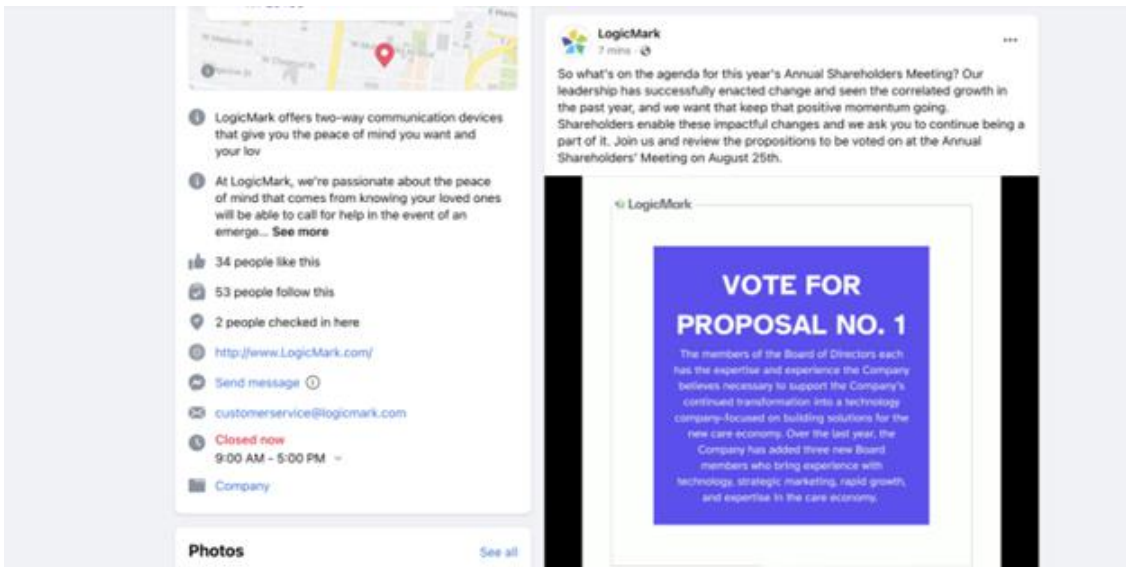
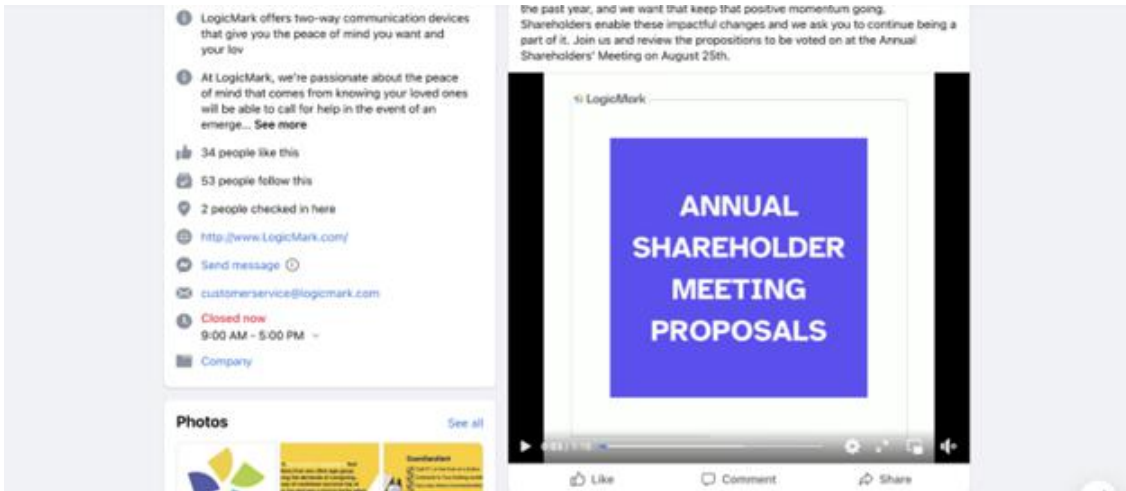
EXPLANATORY NOTE
